- 9. But in case of immoral conduct, misappropriation or embezzlement, fraud, lack of integrity or any other misconduct by you in the discharge of your duties, the organization shall have the right to dispense away with your services forthwith without any notice or compensation

in lieu thereof.

- 10. That you will keep us informed of any change in your current and permanent residential addresses and any other personal particulars.
- 11. This Agreement supersedes any prior agreements, representations or promises of any kind, whether written, oral, express or implied between you and the Company with respect to the subject matters herein. This Agreement may not be modified or amended except by a written agreement between you and the Company.
