



**MEMORANDUM OF UNDERSTANDING
ON
ACADEMIC COLLABORATION
BETWEEN
TeCIP INSTITUTE, SCUOLA SUPERIORE SANT'ANNA
AND
THE LNM INSTITUTE OF INFORMATION TECHNOLOGY**

TeCIP Institute, Scuola Superiore Sant'Anna, and the LNM Institute of Information Technology, Jaipur – LNMIIT, Jaipur hereinafter referred to as “the Parties”,

RECOGNISING the common desire of the Parties to further promote cultural links between India and Italy in view of the scientific and technical advancement of the two Countries and for the benefit of the world community.

INTENDING to actively contribute to the preparation of a technology and scientific co-operation programme between India and Italy to be proposed to the competent Ministries in both Countries.

CONSIDERING that both Parties intend to build up their partnership in the Information and Communication Technology (ICT) sector with a view to leveraging capabilities and opportunities on both sides.

have reached the following understanding:

Art.1 The Parties confirm their intention to promote closer co-operation in the ICT sector in accordance with this Memorandum of Understanding on the basis of equality and mutual benefit.

Art.2 The scope of co-operation between the Parties shall include the following areas of ICT:

- Computer Science and Informatics
- Next Generation Communication and Networking
- Photonics Technologies
- Micro-robotics
- Telemedicine

Art. 3 Beginning from the year 2021, within the above fields of study, the Parties agree the exchange of faculty member (professors, researcher, doctoral/Ph.D students, post-doctoral students, researches fellows) for a short, medium or long period of time, ranging from 1 to 10 months. The exchanging personnel will be considered as “visiting” with reference to the hosting Party. The exchange will be subject to availability of funds and other resources of the Parties, considering that all the expenses related to the visit will be fully supported by the belonging Party, unless other resources could be available (as research project funds). Opportunities will be communicated in due time from one Party to the other.

Art. 4 the number of students admissible each year for the areas at Art. 2 will be communicated to the other Party in due time. Selection of students will be carried out by the two Parties. Preliminary selection of a set of candidates will be carried out by the Party in India, and final selection within such a set will be carried out by the Party in Italy, and viceversa. During the visiting periods the students can be allowed to join didactic or research activities, carried out by the hosting Party. Selected students will be fully supported for travel, lodging, tuition fee, insurance, and to attend Italian language courses, by the belonging Party.

Art. 5 Should intellectual property rights arise out of any activity under this Memorandum of Understanding, the allocation of ownership of these rights shall be determined on a case-by-case basis conjointly by both the Parties, in accordance with eventual pre-existing obligations of the hosting Party, the applicable domestic laws, and the international principles.

Art. 6 The Parties shall designate one representative each to guarantee a stable link and a smooth running of the initiatives:
for TeCIP INSTITUTE - SSSA, Professor Antonella Bogoni will be the contact to develop and coordinate specific activities or programs;
LNM INSTITUTE OF INFORMATION TECHNOLOGY designates Professor Rahul Banerjee for the same purpose;
Any and all disputes between the Parties concerning interpretation and/or implementation of this Memorandum of Understanding shall be settled amicably through consultations and/or negotiations between the representatives.



Art. 7 This Memorandum of Understanding shall come into force from the date of the signature and shall continue for five years, unless it is terminated by either party by giving six months notice in writing of its intention to terminate it.
