College not to deploy Endeavor's staff/faculty directly or indirectly for any assignment/ sessions without prior agreement signed and confirmed.

### Infrastructural Support:

A simple furnished classroom with seating capacity of 60-100 Students (No. of classrooms required may vary with count

of students enrolled and batches launched)

Cleanliness and Hygiene being properly taken care of for the classrooms and facilities used.

White/Black board, Markers, General furniture viz. table, chair etc.

A stationary room with lock to stock inventory and other Endeavor material used for smooth operations at college

L.C.D. Projector and Screen for Audio Visual Classes

Computer Lab with internet connectivity to conduct Online Tests (Students to carry their own laptops, no hardware from

college authorities)

College to allow accommodation arrangement for our faculty members in Campus premises with basic hygiene (Hostels) on Weekdays/ Weekends (as and when required). \*subjected to availability
