- h. Mutual cooperation wherein either party can use name of the other for the purpose of promoting interest under this MoU.
- i. Organization of and participation in conferences, courses, workshops, exhibitions and other joint meetings of mutual interest;
- j. Exchange of technical data and information relating to training material.
- k. Other forms of co-operation as agreed by the Parties, including meetings between the two parties on a regular basis.

Article 3: Confidentiality

Both parties herein shall hold or cause to be held, in strict confidence any and all information relating to this MoU and all related information obtained/received or created/generated/developed by either party, during the course of this MoU.





LNM Institute of Information Technology acknowledges and agrees that the Intellectual Property of Collabera in existence prior to the performance of any Services under this MoU or developed in the course of providing services under this MoU shall remain the exclusive Property of Collabera.

LNM Institute of Information Technology shall not use any Audio and video recording of Seminar/ training sessions for any purpose without Collabera Consent.

Article 4: Payment Terms

Collabera will be Charging nominal fees directly from students who will be enrolling for such courses.

Article 5: Term and Termination

This MoU will be valid from the date herein above mentioned and will remain in force until & unless terminated by either party by giving 30 days prior notice.

The termination of this MoU shall not affect the validity or duration of projects under this MoU that are initiated prior to such termination.
