I have been directed to convey that the Post-Doctoral Fellowship to **Dr. Aditi Swami** has been extended into the second year w.e.f **05.12.2020 to 04.12.2021** to enable his/her to work on the above study. The Extension is subject to the following terms and conditions:


1. During the tenure of fellowship **Dr. Aditi Swami** will be entitled to the following :

The amount of fellowship and contingency grant will be as under:

	<b>For One Year</b>
a. Fellowship amount @Rs.31,000/ p.m. x 12*	Rs.3,72,000/-
b. Contingency grant @Rs.25, 000/- p.a.*	Rs. 25,000/-
	Rs <u>3, 97,000/-</u>


2. The sanctioned grant will be released in three instalments as follows:
  - i. Third instalment Rs.1,98,500/- (6months fellowship with contingency)
  - ii. Fourth instalment Rs. 99,250/- (3months fellowship with contingency)
  - iii. Fifth instalment Rs. 99,250/- (3months fellowship with contingency)Total: Rs.3, 97,000/-.
3. The third instalment of **Rs.1, 98,500/-** will be released on receipt of the enclosed grant-in-aid bill duly signed on a revenue stamp may be furnished immediately on receipt of the sanction order.
4. The fourth instalment of **Rs.99,250/-** will be released on receipt of the detailed six monthly progress report (**Format Enclosed**) and a statement of expenditure in respect of the first instalment of second year of the fellowship.
5. The fifth/final instalment of **Rs.99, 250/-** will be released on receipt of a complete and satisfactory final report and a statement of total amount of fellowship. This should be followed by an audited statement of account and utilization certificate duly signed by the statutory auditors.
6. The contingency grant may be utilized for books, stationery, computer related costs, and the field work expenses connected with the research work.
7. All the fellowships are subject to income tax deductions, which shall be made by the affiliating institution.
8. The accounts and utilization certificate will be signed by the Finance Officer/Registrar/ Principal/Director in case the accounts of the Institution are audited by the CAG/AG. Otherwise, they need to be signed both by the competent authority of the affiliating institution along with a chartered accountant.

9. During the tenure of the fellowship the fellow will be treated as an employee of the University/institution for all the administrative purposes and the rules of the university/ institution shall apply in the matter of draws of TA/DA holidays and contingency grant.
10. If a fellow leaves the fellowship before its full term, he/she has to give an undertaking to submit the final report within a reasonable period but he has to submit a detailed progress report duly forwarded by the Supervisor. In such cases, the ICSSR may consider to pay contingency grant. In other cases, the scholar can leave by refunding the entire amount already released by the ICSSR. If the scholar leaves without completion of the work and without informing the ICSSR, he/she has to refund entire amount of fellowship released with penalty/penal interest.
11. On completion of the fellowship, the scholar should submit the following:
- A book-length final Report in a publishable form along-with a Summary of the report (3000- 4000 words) and research papers published.
  - These documents should be submitted in hard copy (two copies of final report and three copies each of the Summary and research articles) and a soft copy in pen-drive.
  - A certificate of settlement of assets and books purchased out of the fellowship grant, if any, issued by the affiliating Institution.
  - The Report will be evaluated by an independent subject expert appointed by the ICSSR.
12. A maximum of three months period can be granted for submission of the final report after completion of the fellowship.
13. If it appears to the ICSSR at any point of time that the progress or conduct of the fellow has not been satisfactory, his/her fellowship may be suspended or terminated forthwith.
14. All the fellowships are subject to income tax deductions which shall be made by the affiliating institution.
15. In case the report is plagiarized, not received within the stipulated period or modified as suggested by our expert, the fellow will be debarred from any financial support under any scheme of the council including support for visits abroad either as individual scholar or as member a delegation. He/she will also not be associated with any committee/programme that the Council may set up/organize from time to time.
16. Other terms and Conditions mentioned in the fellowship guidelines shall apply
17. **The amount of grant sanctioned herein is to be utilized by stipulated period. Any amount of the grant remaining unspent during this period shall be refunded to the ICSSR immediately after completion of the project. If the grantee fails to utilize the grant for the purpose for which the same has been sanctioned, the grantee will be required to refund the amount of the grant with interest thereon @10% per annum from the date of its sanction.**
