Joining Bonus:

As mentioned, you shall be entitled for a Joining bonus of amount **INR 100,000** (payable in two equal installments). First installment (50%) shall be paid on successful completion of 3 months of service. Thereafter you shall be eligible for the second installment (remaining 50%) on successful completion of probation period (i.e. on confirmation of services).
