for the coordination of the training offer and the research activities through the training and research clusters and for the coordination of the technology transfer

Normandy University and its members hereinafter individually referred to as "the Party" and collectively to as "the Parties".

- 1. It is the will of the Parties to jointly reach a framework for collaboration by virtue of which each party will develop and promote academic activities that will offer "PhD students" and Master students opportunities for education and investment in research projects at international level, notably concerning the XL-Chem Graduate School.
- 2. Each Party's specific intention in entering into this Memorandum of Understanding is to demonstrate to the other Party its respective interest in pursuing a jointly supervised program concerning education and research of Master and PhD students.
- 3. The proposed collaboration between Parties will provide:
 - an opportunity to facilitate international research for PhD and Master students, including
 access to the latest research equipment in the two institutions. The aim will be to achieve
 PhD and master's degrees under joint supervision between the Parties, including cofunding mechanisms, student exchanges, in particular for laboratory internships;
 - a mechanism to enhance cooperation and collaboration between the researchers and the universities involved, in particular by setting up international collaborative projects, but also by the support for courses made in English and lectures by academic researchers;
 - an opportunity to recruit international students of the highest calibre to research training programs.
- 4. The purpose of this Memorandum of Understanding is only to express the intentions of the Parties. The provisions contained in this Memorandum of Understanding are not legally binding on either Party, and no legally binding obligations are intended to, or do, arise as a consequence of the existence or execution of this document. The Parties may then formalize their





collaboration in a legally binding framework agreement, which will define the modalities of their collaboration on the above-mentioned subjects.

- 5. When either or both Parties propose specific projects involving students from either or both of their institutions, as part of the proposed collaboration, each party agrees to appoint an appropriate representative and a specific contract will then be negotiated between the representatives of the parties. The specific contracts will enter into the scope of the above-mentioned framework agreement and will notably provide for the financial terms and conditions concerning the specific project.
- 6. Each Party recognises that the other Party may have arrangements of a similar or different nature with other (persons) partners, whether in each Party's respective countries or elsewhere in the world, during the term of this Memorandum of Understanding.
- 7. This Memorandum of Understanding shall come into force on the date of the last signature and shall remain in force for five (5) years, provided that it shall be terminated by the signature between the Parties of the aforementioned framework agreement and may be terminated by either Party upon six (6) months' written notice to the other Party.
